

**Description:** ON YOUR VEHICLE, THE WHEEL END HUB BOLT IN THE REAR AXLE MAY BECOME LOOSE OR BREAK. CONTINUED DRIVING WITH A BROKEN BOLT MAY LEAD TO WEAR WITHIN THE AXLE AND DAMAGE TO THE AXLE HUB SPLINES.

THIS ISSUE MAY INITIALLY RESULT IN A CLICKING NOISE AS THE BOLT BECOMES LOOSE. IF THE BOLT BREAKS, YOU MAY NOTICE A RATTLE NOISE FROM THE WHEEL CAP AND THE AXLE HUB SPLINES MAY BECOME DAMAGED. VEHICLES WITH DAMAGED AXLE HUB SPLINES MAY ROLL IN PARK WITHOUT THE PARKING BRAKE APPLIED, OR, ALTERNATIVELY, LOSE MOTIVE POWER, BOTH OF WHICH CAN INCREASE THE RISK OF A CRASH.

**Remedy:** PARTS ARE NOW AVAILABLE TO REPAIR YOUR VEHICLE. PLEASE CONFIRM PARTS AVAILABILITY WITH YOUR DEALER WHEN SCHEDULING AN APPOINTMENT. IF ONE OR BOTH SIDES DO NOT CONTAIN THE LATEST PART NUMBER, DEALERS ARE TO REPLACE THE APPROPRIATE AXLE HALF-SHAFT AND HUB ASSEMBLY THAT DOES NOT CONTAIN THE LATEST LEVEL PARTS FREE OF CHARGE.

## Glossary

### **CARFAX Well Maintained - Regular Oil Changes**

CARFAX uses the manufacturer's schedule and assumes normal driving conditions. Dealers and service shops may publish different recommended service schedules.

### **Commercial**

Vehicle was registered for business purposes.

### **First Owner**

When the first owner(s) obtains a title from a Department of Motor Vehicles as proof of ownership.

### **Ford or Lincoln Mercury Recall**

The Ford Motor Company provides CARFAX with Field Service Action and recall information regarding safety, compliance and emissions programs announced since 2000 for a specific vehicle. ### **Manufacturer Recall**

Dealers sometimes opt to take ownership of a vehicle and are required to in the following states: Maine, Massachusetts, New Jersey, Ohio, Oklahoma, Pennsylvania and South Dakota. ### **Title Issued**
